- Field Trip Permission Form (per student)
- Family Form (this form is required especially if the student is staying past 2:00pm)
- Fee of \$20 per student (includes group rate of \$16 + bus rental)
- Andes Rental Slip (if you need to rent equipment from Andes)

PLEASE return all of these at one time to avoid any issues. The cost for adults is \$16 per adult (grade 7+). If you have any questions, please contact the school office. Students will have a school lunch provided for them. Adults and guests must provide their own lunches. Bus space is limited to St. Mary's students only.



2. I will be responsible for the replacement to Andes Tower Hills at full retail price of new equipment and for any loss or damage other than reasonable wear resulting from use.
3. I agree to return all rental equipment the same date as rented in clean condition to avoid any additional charges.
4. I understand and am aware that skiing/boarding is a hazardous activity. I understand that the sport of skiing/boarding and the use of this equipment involve a risk of injury to any and all parts of my body. I hereby agree to freely and expressly assume and accept any and all risk of injury to the user of this equipment.
5. I understand that the ski-boot-binding system will not release at all times or under all circumstances, nor is it possible to predict every situation in which it will release therefore no guarantee of my safety.
6. I hereby release Andes Tower Hills and its owners, and employees from any and all liability for damage and injury to myself or to any person or property resulting from negligence. The selection, adjustment, and use of this equipment accepting myself the full responsibility for any and all such damage or injury which may result.
7. I have made no misrepresentations to Andes Tower Hills in regard to my height, weight, age, skier type, name, address, city, state, ZIP, or phone number.
8. I have carefully read this agreement and release of liability and fully understand its contents. I am aware that this release of liability and a contract between myself and this skiing/boarding shop and I sign it of my own free will.
9. I agree not to transfer any part of this equipment rented to any other skier/boarder.
10. I agree to keep rental equipment on the slopes or in Andes storage racks while renting them. I agree not to bring any equipment including skiing/boarding boots in the parking lot areas of Andes property at any time.
11. I will not use Andes Rental equipment on any terrain park features, jumps, rails or anywhere Andes equipment may be damaged.
